Composting dead livestock - Iowa State University

On-farm composting of dead animals generated on the same farm as the composting facility is exempt from having a permit if: • Dead animals are incorporated into the composting process within 24 hours of death and covered with sufficient animal manure, animal bedding, crop residues or clean wood waste (free of coatings and preservatives) necessary
